SOUTH PLATTE NATURAL **RESOURCES DISTRICT** ORDER AMENDING AND RESTATING THE DISTRICTWIDE GROUND WATER MANAGEMENT AREA RULES AND REGULATIONS

Pursuant to Neb. Rev. Stat. §§46-701 to 46-754, the South Platte Natural Resources District (SPNRD or District) amends and restates its Districtwide Ground Water Management Area Rules and Regulations.

A Public Hearing was held on September 15, 2015 to receive testimony and other evidence regarding the proposed amendments to the SPNRD Districtwide Ground Water Management Area Rules and Regulations.

The District has determined after considering the testimony and other evidence presented at the public hearing, written testimony and other evidence received through October 2, 2015, and whether it reasonably appears that such action will mitigate or eliminate the condition which led to the designation of the management area or will improve the administration of the area, that the proposed Amended and Restated Districtwide Ground Water Management Area Rules and Regulations should be approved and adopted, with modifications.

IT IS THEREFORE ORDERED BY THE SPNRD that the and Restated Amended Rules and Regulations to the Districtwide Ground Water Management Area are approved and adopted and shall become effective November 13, 2015.

B) The addition of Appendix C1 to reflect the amended 2016 through 2018 allocation amounts in Subareas A, B, C, D, E and F. C) Adds Rule

Adds Rule 6.7.1.2: Allocation amounts in Acre-Inches by subarea for the 2016 through 2018 allocation period, which are as follows: Allocation Period

Subarea A – Wyoming State Line to Oliver Reservoir (Road 27) = 42'' (3-year total) Subarea B – Oliver Reservoir (Road 27) to Buffalo Bend

(Road 87) 42 = (3-year total) Śubarea Ć - Buffalo Bend

(Road 87) to Sidney (Road = 42" (3-year total) 115) Subarea D – Sidney (Road 115) to Colorado State Line

Subarea E – South Platte Valley = 48" (3-year total) Subarea F - Tablelands

(3-year total) = 39" In addition, Rule 6.7.1.2.1 provides that Allocations in Subareas A, B, C, D, E and F will have a three (3) year allocation period; and Rule

6.7.1.2.1.1 provides that in 2018 the Board will set Allocations for a new three (3) year Allocation Period, to commence in 2019 for all subareas:

D) Amends Rule 6.7.1.4 (formerly Rule 6.7.1.3), which states that Carryforward of up to 10 Acre-Inches will be allowed following the three (3) year Allocation Period in Subareas A, B, C, D, E and F, and every Allocation Period thereafter. The cap on the amount of Carryforward ("Carryforward Cap") that may be accumulated over multiple Allocation Periods and used in subsequent Allocation Periods is 10 Acre-Inches.

E) Amends Rule 6.7.1.8 (formerly Rule 6.7.1.7), under Supplemental Water Well, which states the Allocations listed for Subareas A, B, C, D and E. in accordance with Rule 6.7.1.1 and adds Rule 6.7.1.2. which will not be reduced by any amount of surface water delivered to or transferred to

Certified Irrigated Acres that would otherwise be irrigated from such Supplemental Water Well.

This Order shall be published once each week for three consecutive weeks in a local newspaper published or of general circulation in the area involved, the last publication of which shall be no less than seven days prior to the date set for the effective date of the Order, all in accordance with Neb. Some seniors handle this by having a friend or relative agree to take the animals when

they can no longer care for them.

Dear Annie: Last month, a dear friend died. He lived in another state, but he was buried here. His family had once been a large part of our community, but none of them has lived in our town for 30 years.

His widow spent a great deal of money on funeral arrangements and meals for the crowd that she expected to attend. I told her that only a few people would remember her husband, but she didn't listen.
